AMENDMENT

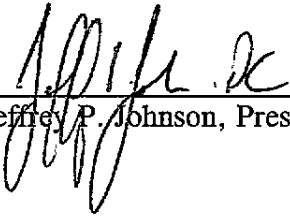
The name of the corporation shall be changed to:

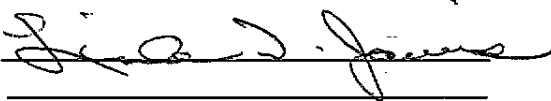
