To Whom It May Concern:

I was dismayed to learn that our corporation by the name of Leturmy Landscaping & Power Spraying, Inc. became inactive as of September 26, 1997. This was brought to our attention, just yesterday, when my son, Jerry Leturmy, who is manager of the business, was at the Division of Workmen's Compensation office in West Palm Beach to apply for an exemption from Workers Compensation.

Our corporation was established June 6, 1986 Document number J18308. Never would I have neglected to return the Annual Report if I had received the notification in the year of 1997. I truly cannot understand what could have happened, other than the fact that we have had problems with our mail being confused with Box 70 instead of being placed in P.O. Drawer 70. Our mailing address has always been P.O. Drawer 70, Boca Raton, Fl. 33429. Whether this may have happened to the report in 1997, I cannot substantiate, however I know I never received it, if I had, I certainly would have filed the report.

As stated earlier, I was in disbelief of this situation. I spoke to one of your representatives, by the name of Margueretta this morning and she advised me to send a letter stating the facts that this situation was unknown to me and that I wish to have the corporation re-instated. She instructed me to send a check for \$915.00 covering the years from 1997 through year 2002. Hopefully this matter can be resolved immediately.
