ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE ATHENA GROUP, INC.



TO: Department of State Tallahassee, Florida 32304

Pursuant to the provisions in Section 607.1003 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation pursuant to a meeting of the shareholders of the Corporation duly called on March 23, 2001:

1. The following amendment to the Articles of Incorporation of The Athena Group, Inc. was adopted by holders of a majority of the outstanding shares of the common stock of the corporation on March 23, 2001, in the manner prescribed by the Florida General Corporation Act. The portion of Article V relating to common stock is hereby amended as follows. Those portions of the Articles of Incorporation, as amended, defining the number and rights of preferred shares are unaffected by this amendment.

ARTICLE V CAPITAL STOCK

The Athena Group, Inc. is authorized to issue 10,000,000 shares of Common Stock with a par value of .001/100 Dollars (\$.001) per share

- 2. The number of shares of the corporation outstanding at the time of such adoption was 100,000 shares common stock; and the number of shares entitled to vote thereon was 100,000 shares common stock.
- 3. The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

4. Number of shares voted for the amendment of Article V was 93,000; the number of shares voted against such amendment was 0; the number of shares abstaining was 0; and the number of shares not represented at the meeting in person or by proxy was 7,000.

5. The number of votes cast by a majority of the holders of common stock in favor of the amendment of Article V was sufficient for approval by the common stock shareholders.
