In regard to your Letter Number. 701A00040634, respectfully I have explained the reason for not filling, 2001 UNIFORM BUSINESS REPORT, on time.

In mid October 1999, I felt pain and discomfort in my abdomen, following home rest and check up, I was operated twice in November followed by recovery home rest and follow up treatment for entire month of December.

95% of Americool jobs was Governmental and Public Institutions, and because of the year budget allocation, bedding period for those type of projects is mainly three months of October, November, and December. I was the only estimator and job provider, that I fail to perform due my health condition. As a result, we were not able to get any new project.

At the beginning of the new year as each on going project was completed, our employee left one by one. The last person was the accountant, who part-time took care of the accounts and necessary documents for job close out.

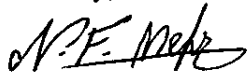
Soon after all existing projects were completed, my presence in office reduced to one or two hours for each visit, (that was normally biweekly and some times weekly) for remaining year of 2000 and first half of year 2001. In this period, I was out of town for most of the time, and my brother house keeper took care of my office mails, and mails could go unopened for few months.

For last fifteen years, my accountant was in charge of renewing all licenses and corporation filling, and I have very limited knowledge. I do not remember if I received any renewal reminder from you, or the house keeper could not determined the importance of the report and along with the rest of junk mails dispose it.

At the present time I am straggling to manage the rent and other overhead expenses till I find someone to help me financially and physically. I have no money for my personal expenses, office expenses, and penalty for late filling fee of corporation report.

Your prompt attention to this matter is greatly appreciated, and please accept my apology for this tedious letter.
