**SECOND RESTATED  
ARTICLES OF INCORPORATION  
OF  
CONTINUCARE CORPORATION**

Pursuant to Sections 607.1003 and 607.1007 of the Florida Business Corporation Act, CONTINUCARE CORPORATION, a Florida corporation (the "Corporation"), certifies that:

These Second Restated Articles of Incorporation amend and restate the Restated Articles of Incorporation, as amended, in its entirety. These Second Restated Articles of Incorporation were duly adopted and approved by the Corporation's board of directors by written consent dated October 4, 2011 and by the Corporation's sole shareholder by written consent dated October 5, 2011.

The text of the Corporation's Restated Articles of Incorporation, as amended, is hereby amended and restated in its entirety, effective as of the date of filing of these Second Restated Articles of Incorporation with the Secretary of State of Florida, to read as follows:

**ARTICLE I - NAME**

The name of the corporation is "Continucare Corporation" (the "Corporation").

**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of the Corporation is 777 Yamato Road, Suite 510, Boca Raton, Florida 33431.

**ARTICLE III - SHARES**

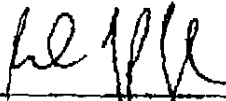
