I spoke on the phone today with a Division of Corporations representative who requested that I send in \$150.00 along with our reinstatement application and a short note explaining our situation.

In April, 1998, we relocated our offices, and I notified the Division of Corporations of our new address. Shortly thereafter, I checked the Division's web site and found that the address indicated for our office was incorrect. I called the Division, and followed up with a letter, requesting that our address be corrected. For some reason, the address indicated included our new street address, our old suite number and a zip code which I am unfamiliar with.

I had assumed that our address had been corrected in your records. However, this past week, we received a notice indicating that our corporation had been dissolved due to the lack of filing of an annual report.
