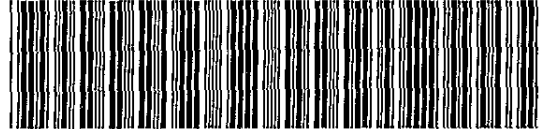

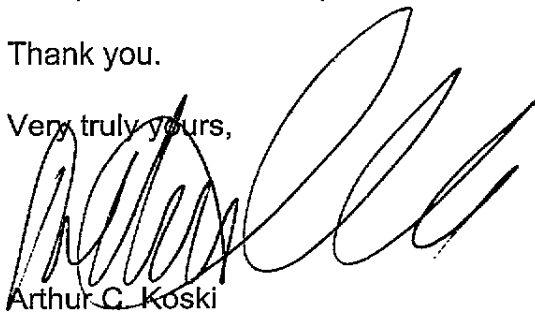

**ARTICLES OF AMENDMENT OF
MUMMAW AND ASSOCIATES, INC.**

Pursuant to Florida Statutes Section 607.1006 , the Articles of Incorporation of the above-named Corporation are hereby amended as follows:

1. ARTICLE I - NAME is hereby amended to read as follows:

The name of the Corporation shall be:

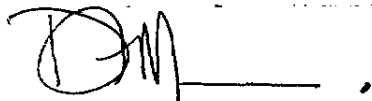
MUMMAW, BOUZA, AND ASSOCIATES, INC.
