ARTICLES OF DISSOLUTION
OF
THE BLUFFS MARINA, INC., a Florida corporation

Pursuant to the provisions of Section 607.1403 of the Florida Statutes, these Articles of Dissolution provide that:

ARTICLE I - NAME
