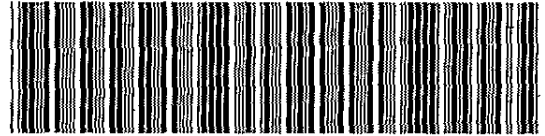

FOURTH: The amendment was adopted by the shareholders and directors.

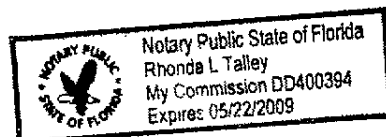
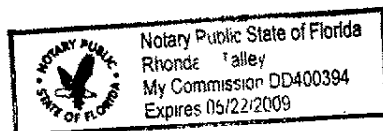

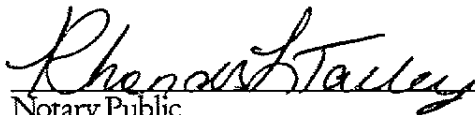
