ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
HERTNER, BLOCK & ASSOCIATES, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of HERTNER, BLOCK & ASSOCIATES, INC. (the "Corporation") as originally filed on January 2, 1987, under document no. J51175, as amended, are hereby amended according to these Articles of Amendment:

FIRST: Article I and Article II of the Articles of Incorporation of the Corporation are hereby amended to read as follows:

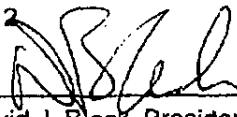
ARTICLE I. The name of the corporation is: HERTNER, BLOCK & BOWSER, INC.
