Wholly fortuitously, in connection with the need to give proof of corporate existence, I discovered within the last couple of days that according to the records of the Corporations Division, my personal service corporation, *Douglas L. Williams P.A.*, was "Administratively Dissolved" due to failure to provide or file annual reports since the year 2001.

I am absolutely at a loss to understand how such a thing could happen: as a practicing attorney of long-standing, I am more than passingly familiar with the need to maintain "good" (i.e. valid) corporate standing and status, and the notion that either I or anybody in my employ would causally and constantly fail or overlook simple notices requiring annual reports is simply beyond possibility.
