AMENDED AND RESTATED ARTICLES OF INCORPORATION-OF SIMPLER CORP.

<u>FIRST</u>: The name of the Corporation is SIMPLER CORP., whose Articles of Incorporation were originally filed with the Secretary of State in Tallahassee on August 14, 1987.

SECOND: This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under the provisions of Chapter 607, Florida Statutes.

THIRD: The total authorized capital stock and total number of shares of all classes of stock that the Corporation shall have the authority to issue is 1,000 shares of common stock, divided into two classes as follows:

- (2) 990 shares of Class B nonvoting common stock, no par value, no share of which shall be entitled to vote on any matter submitted to, or required to be voted or acted upon by, the shareholders of the Corporation, unless required by law; holders of Class B nonvoting common stock shall not be entitled to vote such shares nor to receive notice of any meeting of shareholders unless required by law.

Except as otherwise provided above, or by law, each share of stock shall be equal to each other share, including with respect to dividend or liquidation distributions or other similar rights.

FOURTH: The street address of the initial Registered Office is 4300 Ocean Beach Blvd., Cocoa Beach, Florida 32931 and the name of the initial Registered Agent of this Corporation at that address is Karen Simpler.

FIFTH: The street address of the principal office of this Corporation is 4300 Ocean Beach Blvd., Cocoa Beach, Florida 32931.

SIXTH: The duration of this Corporation is perpetual.

<u>SEVENTH</u>: This Corporation shall have one (1) Director initially and the number of Directors may be increased or diminished from time to time as provided in the By-Laws of this Corporation but shall never be less than one (1).
