**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
20/20 EYECARE CENTER, INC.**

The following provisions of the Articles of Incorporation of 20/20 EYECARE CENTER, INC., a Florida corporation, filed on August 28, 1987, be and they hereby are amended in the following particulars:

1.) Article I is amended to read as follows:

“The name of the corporation is 20/20 Eyecare Center, P.A.”

2.) Article III is amended to read as follows:

“This corporation is organized for the following purposes:

a. To engage in the practice of optometry as a professional corporation and to own and operate an eye clinic for the purposes of providing optometric services.

b. To furnish related laboratory and clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional optometric services.

c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to render optometric services in the state of Florida.”

3.) Article VI is amended to read as follows:

“The initial Board of Directors shall consist of two (2) members whose names and addresses are as follows: Allen I. Sobel, 1829 E. Colonial Drive, Orlando, FL 32803 and Steven Sobel, 1829 E. Colonial Drive, Orlando, FL 32803.

The number of directors subsequent to the initial Board of Directors may be increased or decreased from time to time, as provided in this corporation's Bylaws, but shall never be less than one.

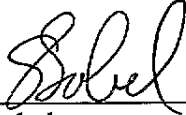
Each director shall hold office for a term of one (1) year or until his successor shall have been elected and qualified or until his earlier resignation, removal from office, or death."

The foregoing amendments were unanimously approved and adopted by the Shareholders of the corporation on the 31<sup>st</sup> day of December, 1998.

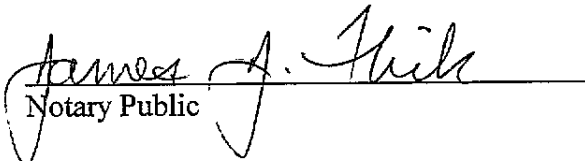
