SECOND: The following Amendments to the Articles of Incorporation were adopted by the corporation:

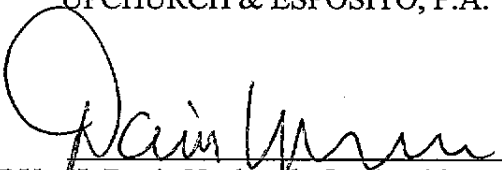
The president of the corporation is hereby changed to **H. DAVIS UPCHURCH, JR.**

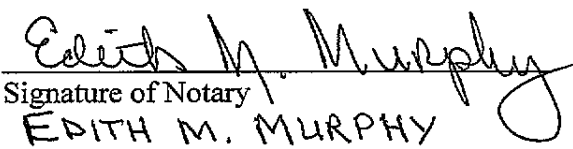
