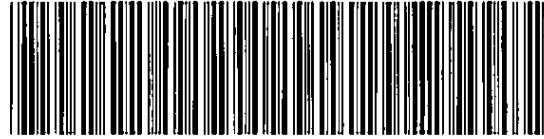

ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of this Corporation is:

FLORAIL, INC.

ARTICLE II

DURATION

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Secretary of State, State of Florida.

ARTICLE III

PURPOSE

that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

INCORPORATOR

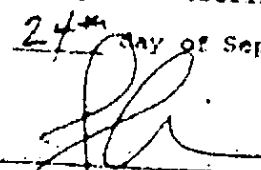

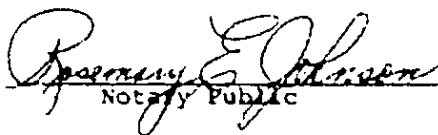
