1. Name of Corporation: COLLMAN & KARSKY ASSOCIATES, P.A.
2. Amendments Adopted: The Articles of Incorporation of the corporation are hereby amended and restated by deleting ARTICLES I through X and inserting in place thereof the following provisions:

**"ARTICLE I - Name and Address**
