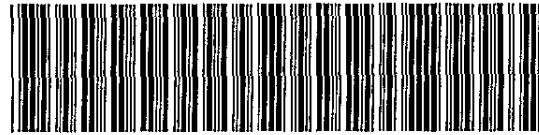

ARTICLES OF AMENDMENT  
to  
ARTICLES OF INCORPORATION  
of
