## AMENDMENT TO THE ARTICLES OF INCORPORATION OF CROSS INTERAMERICA, INC.

O, MA TO MASO, The undersigned does hereby execute, acknowledge and file the following

- 1. The name of the corporation is currently CROSS INTERAMERICA, INC.
- 2. The date of the filing of the Articles of Incorporation was July 8, 1988.
- The Articles of Incorporation are hereby amended as follows: 3.

the Articles of Incorporation of CROSS INTERAMERICA, INC.

By deleting all of Article IV of the Articles of Incorporation, and by a. substituting in lieu thereof, all of the following:

## "ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock of this corporation that may be issued is 500, consisting of (100) voting common shares having a par value of \$1.00 per share (the "Voting" shares) and (400) nonvoting common shares having a par value of \$1.00 per share (the "Non-Voting" shares). Each class of shares shall be identical in all respects, except that the Non-Voting shares shall carry no right to vote for the election of directors of the corporation, and no right to vote on any matter presented to the shareholders for their vote or approval except only as the laws of the State of Florida require that voting rights be granted to such Non-Voting shares."

- In all other respects, the Articles of Incorporation shall remain unchanged. b.
- This Amendment was adopted by a written statement signed by the shareholders 4. and directors of CROSS INTERAMERICA, INC. on the 27th day of MARCH pursuant to Section 607.1003 of the Florida Statutes.

5. The effective date of this Amendment shall be upon the filing of these Articles of Amendment to Articles of Incorporation with the Secretary of State of the State of Florida.

IN WITNESS WHEREOF, the undersigned, being the President of the above named corporation, does hereby make and files this Amendment to the Articles, hereby declaring and certifying that the facts herein stated are true, and executes this Amendment to the Articles of Incorporation this 27th day of MARCH, 2001.
