ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF LAKELAND PATHOLOGISTS, P.A.

1. Article IV, entitled CAPITAL STOCK, of the Articles of Incorporation of LAKELAND PATHOLOGISTS, P.A., a Florida professional service corporation (the "Corporation") (Document Number K49429), is hereby amended to read as follows:

"ARTICLE IV. - CAPITAL STOCK

The aggregate number of shares of stock that the corporation shall have the authority to issue is 20,000 shares of common stock, of which 10,000 shares shall be designated Class A common shares with a par value of \$1.00 per share (referred to herein as the "Class A Voting Common Stock") and of which 10,000 shares shall be designated Class B common shares with a par value of \$1.00 per share (referred to herein as the "Class B Non-Voting Common Stock"). The consideration to be paid for each share shall be as fixed by the board of directors and may take the form of cash, property, interests in property or any other form deemed satisfactory to the board of directors if, in the judgment of the board of directors, such consideration has a value equivalent to or greater than the full par value of the shares.

The Class A Voting Common Stock and the Class B Non-Voting

Common Stock shall each have the same preferences, limitations and

relative rights (including, without limitation, identical rights to

distribution and liquidation proceeds) with the sole exception that only shares of the Class A Voting Common Stock shall have voting rights and no shares of the Class B Non-Voting Common Stock shall have voting rights. All shares of the Class B Non-Voting Common Stock shall be plainly stamped "Non-Voting". The holders of the shares of the Class B Non-Voting Common Stock shall not be entitled to notice of any meetings of shareholders and shall not be entitled to vote upon any matter whatsoever which may be presented and decided upon at any meeting of the shareholders. However, the record holders of shares of the Class B Non-Voting Common Stock shall be entitled to participate share for share with the record holders of shares of the Class A Voting Common Stock in any dividends or distributions in liquidation which may hereafter be declared and paid or otherwise made by the corporation.
