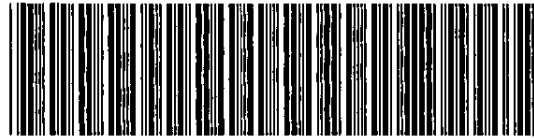

3. The Articles of Incorporation shall remain otherwise unaffected by such amendment.


4. The above Articles of Amendment were approved by unanimous consent of the Shareholders and Directors on December 14, 2012.
