Dear Sir or Madam:

This is in response to the "Notice of Administrative Dissolution or Revocation" we received via mail today. The dissolution notice was completely unexpected, as we had not yet received a Corporation Annual Report notice this year. Without notices, it is impossible to remember all the fees, licenses, forms, etc. our corporation must submit. Therefore, we request that you cancel the dissolution of our corporation immediately. We do not feel our corporation should have to pay the reinstatement fee because of circumstances beyond our control.

Although we have tried several times in the past to get our mailing address corrected, it is still incorrect. The 1998 form we submitted (attached) shows the correction we made to that form. The dissolution form, also attached, shows that our mailing address still has not been corrected. Because the error still exists, we believe the notices may have been sent to an old address.

We request that you cancel the dissolution of our corporation, accept the standard \$150.00 annual filing fee along with a completed Application for Reinstatement form (in place of the 1999 Corporation Annual Report form we never received).
