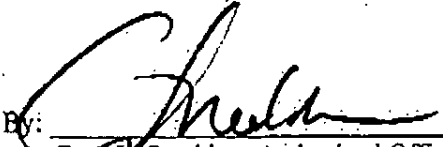
**ARTICLES OF DISSOLUTION

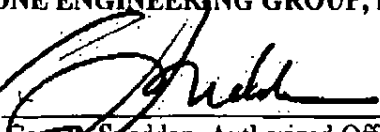
1. The name of the Corporation is Stone Engineering Group, Inc.
