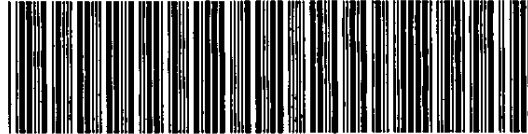

FIRST: The corporate name that satisfies the requirements of Section 607.0401 is: FEDERAL HOUSING CORPORATION.

SECOND: The address of the principal office, is:

THIRD: The number of shares the Corporation is authorized to issue is: One Million (1,000,000) shares without par value.

FOURTH: (a) The shares are to be divided into classes, and the designation of each class is:

Preferred Stock	800,000	Class "A"
Common Non-Voting Stock	100,000	Class "B"
Common Voting Stock	100,000	Class "C"

(b) Statement of the preferences, limitations and relative rights in respect of the shares of each class and series is to be specified by directors upon designation and authorization.

FIFTH: (a) The corporation may issue the preferred shares in series, the designation of which is shall be as follows:

First Series	100,000	shares
Second Series	100,000	shares
Third Series	100,000	shares
Fourth Series	100,000	shares
Fifth Series	100,000	shares
Sixth Series	100,000	shares
Seventh Series	100,000	shares
Eighth Series	100,000	shares

The directors shall determine the relative rights, privileges, preferences of each serie upon issuance

(b) Statement of the variations in the relative rights and preferences as between series may be authorized and defined by a majority of the directors.

(c) Statement of any authority to be vested in the Board of Directors to establish series and fix and determine the variations in the relative rights and preferences between series: Full and unfettered authority.

SIXTH: This corporation shall have a perpetual existence.

SEVENTH: Provisions for the regulation of the internal affairs of the corporation are:

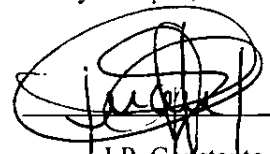
- (a) The shareholders' rights shall be determined by directors' resolution.

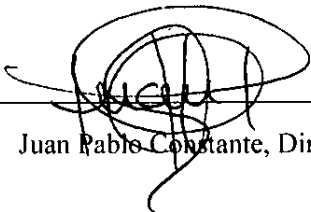
