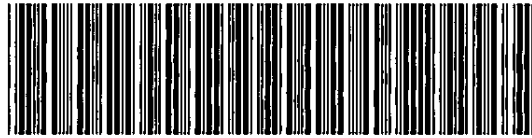




**Article I

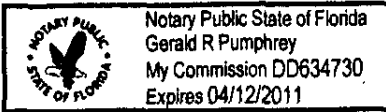
