ARTICLES OF ORGANIZATION

OF

ST. JOSEPH'S, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be St. Joseph's, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address of the Company shall be P.O. Box 11251, Naples, Florida 34101-1251; and the street address of the principal office of the Company shall be 6325 Tall Cypress Circle, Greenacres, Florida 33463.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company shall have perpetual existence until it is dissolved and its affairs wound up.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- MANAGEMENT

The manager shall have full power and authority to manage, administer and operate the business and affairs of the Company for the purposes for which it was created, including the power to deal with title to real property on behalf of the Company, which shall include, the power to (i) enter into agreement(s) for purchase and sale, (ii) assign all or part of the Company's interest in agreement(s) for purchase and sale (iii) execute deed(s), note(s) and mortgage(s), (iii) enter into land trust agreement(s) pursuant to Section 689.071 of the Florida Statutes; (iv) assign all or part of the Company's beneficial interest in land trust agreement(s); (v) execute all loan related documents and (vi) execute all other instruments relating to real property necessary to accomplish the purposes of the Company. 
