

**ARTICLES OF ORGANIZATION**

**HOME DYNAMICS SIENNA, LLC**

David Schack, as the Initial Member forms Home Dynamics Sienna, LLC, a limited liability company, and adopts the following Articles of Organization:

**ARTICLE I. Name:** The name of the Limited Liability Company is Home Dynamics Sienna, LLC (the "Company").

**ARTICLE II. Members:** The initial Member of the Company shall be David Schack. Additional members may be admitted as provided in the Operating Agreement.


**ARTICLE III. Management:** The management of the Company shall be vested in the Members, as may be more particularly provided by the Members in the Operating Agreement.

**ARTICLE VI. Operating Agreement:** The Company shall be operated in accordance with the provisions of the Operating Agreement which shall be entered by the Members. The Operating Agreement shall govern the admission of new members of the Company, assignability of ownership interests in the Company, termination and dissolution of the Company, distributions, the obligations and rights of the members and any other matters which the Members shall provide therein. Otherwise, the Company shall be governed by Florida law, and in particular the provisions of Chapter 608 of the Florida Statutes.


