**ARTICLES OF ORGANIZATION
OF
PECK GENERAL, L.L.C.
"Limited Liability Company"**

The undersigned organizer hereby forms a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (1997), and adopts as the Articles of Organization of such limited liability company the following:

ARTICLE I

The name of the limited liability company shall be **PECK GENERAL, L.L.C.** (the "**Company**").

ARTICLE II

The period of its duration shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE III

The Company shall have unlimited power to engage in and do any lawful act concerning any or all lawful business for which limited liability companies may be organized according to the laws of the State of Florida, excluding banking and insurance, including all powers and purposes now and hereafter permitted by law to a limited liability company.

ARTICLE IV

ARTICLE VI

The members of the company shall contribute to the capital of the company the cash or property as set forth in the Articles of Membership and Contributions attached hereto.

ARTICLE VII

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.

ARTICLE VIII

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE IX

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members.

ARTICLE X

The company shall be managed by one or more managers in accordance with regulations adopted by the members for the management of the business and affairs of the company. The regulations may contain any provisions for the regulation and

management of the affairs of the company not inconsistent with law or these articles of organization. The names and addresses of the initial managers of the company are:

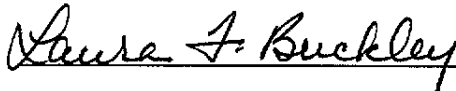

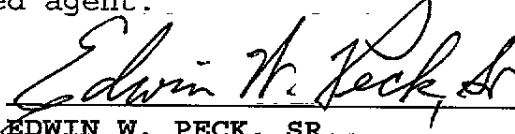
