ARTICLE I.

PREAMBLE; FORMATION

The undersigned, TERRY PURDY, GARY NICKOLS, PAUL HOSTETLER, CARL HEINSMAN, WAYNE BURKHART, and RANDY WHITE, do hereby form a Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, titled as the "Florida Limited Liability Company Act," as hereinafter set forth.

ARTICLE II.

NAME; PLACE OF BUSINESS; AND REGISTERED AGENT

A. Name. The name of this Limited Liability Company shall be SHAKETT CREEK VILLAGE, L.L.C.

B. Place of Business. The principal place of business and the mailing address of the Limited Liability Company shall be 1070 Technology Drive, Nokomis, Florida 34275.

C. Registered Agent. The initial registered agent of the Limited Liability Company shall be STEVEN W. MacCRIS, whose address is 227 Pensacola Road, Venice, Florida 34285.

ARTICLE III.

PERIOD OF DURATION

This Limited Liability Company shall commence its

existence on the date these Articles of Organization are filed with the Florida Department of State. The Limited Liability Company's existence shall terminate on the sooner of the following: (a) when it no longer owns any interest in any lots or any of the common areas of the proposed new development in Nokomis, Sarasota County, Florida, to be known as Shakett Creek Village; or (b) thirty (30) years from the date these Articles of Organization are filed.

ARTICLE IV.

MANAGEMENT BY MEMBER

The Limited Liability Company is to be managed by a Manager. The name and address of the Manager is as follows:

ARTICLE V.

TERMINATION OF EXISTENCE

ARTICLE VII.


AMENDMENTS

These Articles may be amended at any time and from time to time by vote by unanimous agreement of the Members and such amendments shall be filed with the Department of State.


