

## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF RADIOLOGY ASSOCIATES OF CENTRAL FLORIDA, P.L.

FIRST: The date of filing of the Articles of Organization was March 13, 2000.

SECOND: The following amendments to the Articles of Organization of the Limited Liability Company were adopted by all of the Members of the Limited Liability Company:

1. The following shall be inserted as Article 8, Management, in the Articles of Organization:

## Article 8 - Management
