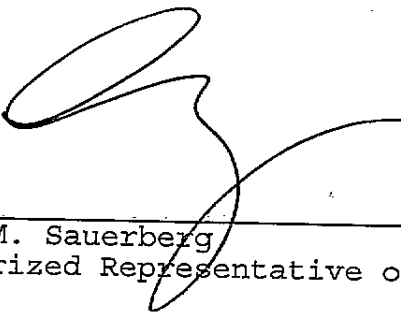
ARTICLE ONE
