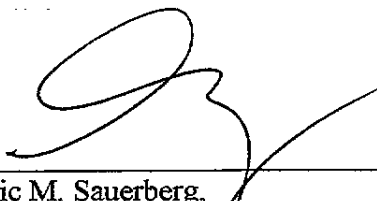
ARTICLE V

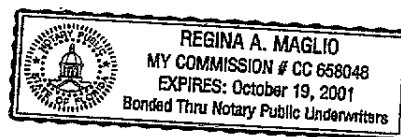

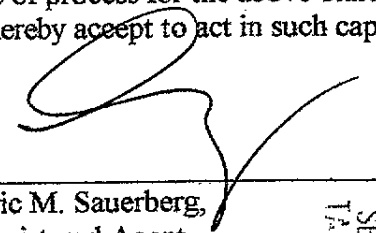

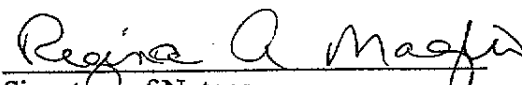
