## **ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization;

#### **ARTICLE I**

**NAME:**

The name of the Limited Liability Company shall be **SABAL COMPONENTS, L.L.C.**

#### **ARTICLE II**

##### **MAILING and STREET ADDRESS**

The mailing address and principal place of business of the Company in Florida shall be 3008 Manatee Ave., Bradenton, Florida, 34205

**DURATION:**

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall terminate no later than March 15, 2030 unless the Company is earlier dissolved as provided in these Articles of Organization.

The general purpose for which the Company is organized is to transact any lawful business for which a Limited Liability Company may be organized under the laws of the State of Florida. ### **TERMINATION OF EXISTENCE**

**The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member of the Company, unless the business of the Company is continued by the consent of a majority in interest of the remaining members.**

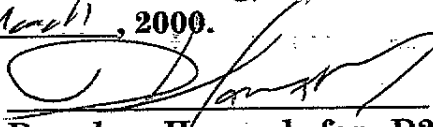
## **ARTICLE VIII**
