C & M LEASING, L.L.C.**

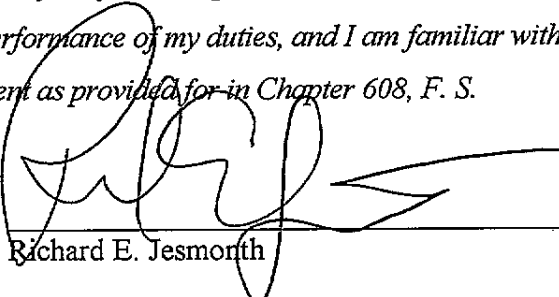

**Article II: Mailing Address:** The mailing address and the street address of the principal office of the limited liability company shall be 2 Via Verona Palm Coast, Florida 37137.

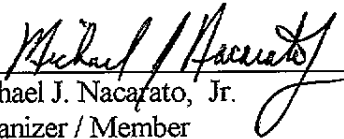
