ARTICLE I -- NAME

The name of the limited liability company shall be PINECREST II MOBILE HOME PARK, LLC (the "company").

#### ARTICLE VI -- MEMBERS' RIGHT TO CONTINUE BUSINESS

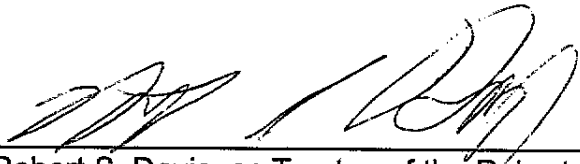
