Admission of Additional Members

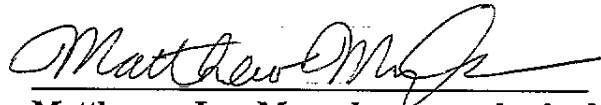
