


## ARTICLES OF ORGANIZATION

### HOME DYNAMICS SIERRA RANCH, LLC

David Schack, as the Initial Member forms Home Dynamics SIERRA RANCH, LLC, a limited liability company, and adopts the following Articles of Organization:

- ARTICLE I.**        **Name:** The name of the Limited Liability Company is Home Dynamics Sierra Ranch, LLC (the "Company").
- ARTICLE II.**        **Members:** The initial Member of the Company shall be David Schack. Additional members may be admitted as provided in the Operating Agreement.
- ARTICLE III.**        **Management:** The management of the Company shall be vested in the Members, as may be more particularly provided by the Members in the Operating Agreement.
- ARTICLE IV.**        **Address:** The mailing address and street address of the principal office of the Limited Liability Company is 7954 Pines Boulevard, Pembroke Pines, FL 33024.
- ARTICLE V.**        **Initial Registered Agent:** The name and street address of the initial registered agent for service of process in Florida is Edward J. Schack, 7954 Pines Boulevard, Pembroke Pines, FL 33024.
- ARTICLE VI.**        **Operating Agreement:** The Company shall be operated in accordance with the provisions of the Operating Agreement which shall be entered by the Members. The Operating Agreement shall govern the admission of new members of the Company, assignability of ownership interests in the Company, termination and dissolution of the Company, distributions, the obligations and rights of the members and any other matters which the Members shall provide therein. Otherwise, the Company shall be governed by Florida law, and in particular the provisions of Chapter 608 of the Florida Statutes.
