**ARTICLES OF ORGANIZATION
OF
KATALYX FOOD SERVICE, LLC**

ARTICLE I

The name of the limited liability company (hereinafter called the "limited liability company") is KATALYX FOOD SERVICE, LLC.

ARTICLE II
