ARTICLES OF ORGANIZATION OF SEYMOUR POWERS CORPORATION, L.L.C. A FLORIDA LIMITED LIABILITY COMPANY

THE UNDERSIGNED, SEYMOUR R. POWERS, pursuant to Florida Statutes 608.407 does hereby execute these Articles of Organization of SEYMOUR POWERS CORPORATION, L.L.C. ("the Limited Liability Company") for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act and does state and set forth:

- The name of the Limited Liability Company is SEYMOUR POWERS CORPORATION, L.L.C.
- The period of duration of SEYMOUR POWERS CORPORATION, L.L.C. shall be perpetual.
- 3. The mailing address and street address of the principal office of the Limited Liability Company is C/O MacLean and Ema, 2600 NE 14th Street Causeway, Pompano Beach, Florida 33062.
- 4. The name of the initial registered agent in Florida for the Limited Liability Company is LAURA G. MACLEAN, and her street address is C/O MACLEAN AND EMA, 2600 N.E. 14TH STREET CAUSEWAY, POMPANO BEACH, FLORIDA 33062. The acceptance of LAURA G. MACLEAN as registered agent appears after the execution of these Articles of Organization below.
- No members shall be allowed to admit additional members except by a unanimous vote of the voting members of the Limited Liability Company, or upon such greater vote as may be prescribed by the Limited Liability Company regulations.
- 6. The Limited Liability Company shall not dissolve and the remaining members of the Limited Liability Company shall continue its business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company.
- 7. The management of the Limited Liability Company is reserved to its managing members. The names and addresses of the voting members who chose its managing members of the Limited Liability Company are:
 - a. SEYMOUR R. POWERS, Trustee of the Seymour R. Powers Revocable Trust Agreement dated 8/14/89, 4869 Tallowood Lane, Boca Raton, FL 33487, managing member and voting member.

- b. ALICE M. POWERS, Trustee of the Alice M. Powers Revocable Trust Agreement dated 4/27/94, 4869 Tallowood Lane, Boca Raton, FL 33487, managing member and voting member.
- c. MELVIN J. POWERS, Commerce Park, Finance Drive, Danbury CT 06810, voting member.
- d. GARRY KEPNISS, 20219 Ocean Key Drive, Boca Raton, voting member.
- e. JOSEPH A. FIORITA, JR., CPA, C/O Fiorita, Kornhass, Van Horten, P.C., 146 Deer Hill Avenue, Danbury, CT 06810 member.
- 8. All other matters regarding the relative rights of the voting and non-voting members of the Limited Liability Company, and the operations of the Limited Liability Company shall be determined by the Limited Liability Company regulations. The power to adopt, alter, amend, or repeal the regulations of the Limited Liability Company shall be vested in the voting members of the Limited Liability Company.
- 9. Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.
