TO ARTICLES OF ORGANIZATION
OF
DOCTORS MEDICAL PLAZA, LLC

The undersigned being one of the members named in the Articles of Organization of Doctors Medical Plaza, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:
