**ARTICLES OF ORGANIZATION OF
CRAFTSMAN MACHINERY & HYDRAULICS, L.L.C.**

Pat Sullivan, a natural person competent to contract, presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of this limited liability company is:

CRAFTSMAN MACHINERY & HYDRAULICS, L.L.C.

This limited liability company is referred to in these articles as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Company shall be 55 South B. Street, Pensacola, Florida 32501. The initial registered agent of the Company is Pat Sullivan.

ARTICLE VI - MANAGEMENT

The Company will be managed by its Member. The name and address of the initial Member is: Pat Sullivan

ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS

The initial member of the Company is Pat Sullivan. New members shall be admitted to the Company only upon the unanimous agreement of the members or upon the failure of a member to exercise the right of first refusal described in the regulations of the Company.

ARTICLE VIII - MEMBERS RIGHT TO CONTINUE BUSINESS

Upon the bankruptcy, dissolution, death or withdrawal from Company of a member, the remaining member or members of the liability company shall have the right to continue the business of the Company.

ARTICLE IX - COMMENCEMENT OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the offices of the Secretary of State of Florida.
