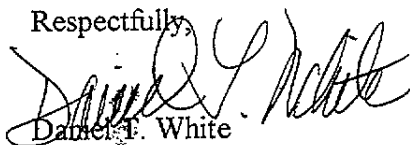

This Company will be a managed by one or more managers, and will be a manager-managed company.

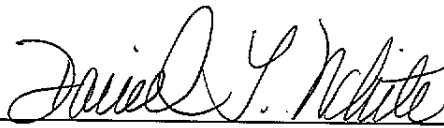
