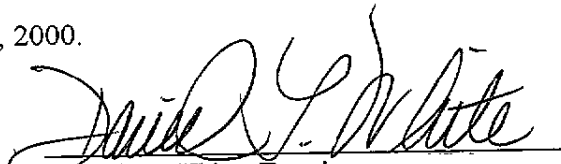
"Article VII: Organizer

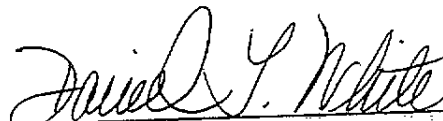

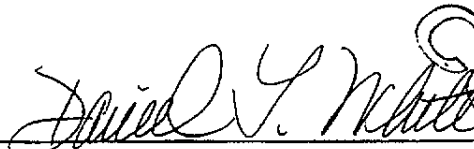
