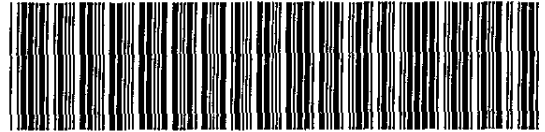


**ARTICLES OF AMENDMENT
