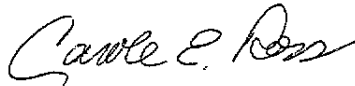

**ARTICLE I
NAME OF LIMITED LIABILITY COMPANY**

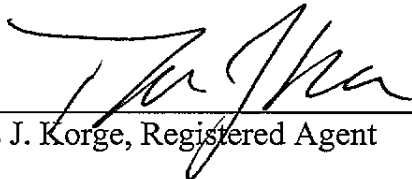
