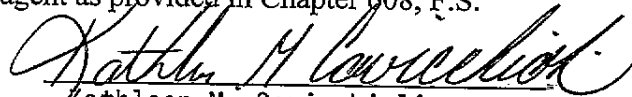

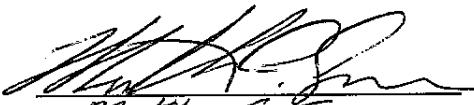
**ARTICLE IX
MEMBERS RIGHT TO CONTINUE BUSINESS**

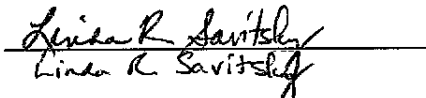
