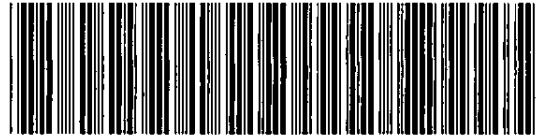

4.


All the remaining property and assets of the Company have been distributed to its sole member.


