NEW LEADERS IN FERTILITY ENDOCRINOLOGY, L.L.C.**



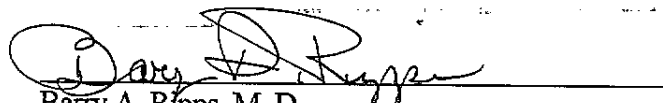
