

The name of this Limited Liability Company is "SHACKELFORD PROPERTIES 67 ISLE OF BAHIA, LLC".


**ARTICLE II.**

The name and address of the limited liability company's registered agent is John P. Shackelford, Jr., 105 Cutter Court, Ponte Vedra Beach, Florida 32082.


