ARTICLES OF ORGANIZATION OF
JEFFERSON COUNTY TRANSPORTATION SERVICES, L.L.C.

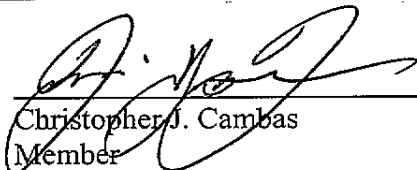
ARTICLE VI

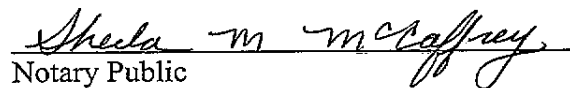

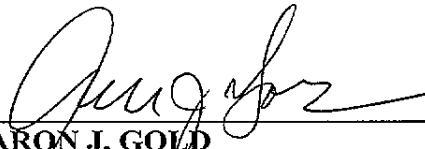
