**ARTICLES OF ORGANIZATION**  
**OF**  
**MIAMI-DADE HEALTH NETWORK, LLC**  
**A Florida Limited Liability Company**

**ARTICLE I**

The company may admit additional members at any time at the sole discretion of the manager(s).


### ARTICLE X


